



Far East Catchment

- Work has been completed on the **Genoa River** treating Cape Ivy, Bridle Creeper, English Ivy and Blackberry. This project included 0.8ha of weed control through a Landcare Grant to the Genoa Town Committee.
- Willow control works were completed on the **Cann River** from Gauge Track to the Mouth.
- Structure repairs will commence on the **Cann River** in the coming months. Repair work was identified as being required on previously installed structures after an inspection on the continuing functionality of each structure was undertaken.

Snowy Catchment

- Willow removal in **Craigneish Creek** will begin in the coming week. These willows had previously been poisoned and are a risk to the public.
- Willow Surveillance from Willis to Jarrahmond has begun on the **Snowy River**.
- Works on the **Buchan River** continue in preparation for planting in the coming months.

Mitchell Catchment

- Work continues on the Lower **Mitchell River** upstream of Nagle College to the Bairnsdale Township, with willow control starting Monday 27 February. This project will also include follow up revegetation which will be completed in autumn.
- Willow Control works will be completed on the Upper **Mitchell River** within the coming week. This pass was a continuation from last year's project with works continuing to the confluence of the Wentworth River this year.
- Willow Control on the **Moroka River** and associated tributaries has been completed with several Cinerea being located within the Moroka river system.



Moroka Falls

- Willow control on the **Little Dargo River** has been completed.
- Willow control will commence on the Lower **Mitchell River** in the coming week. Completing 500 meters of frontage in preparation for revegetation and removal.
- Flood Response- Bank stabilisation works have commenced on the **Mitchell and Dargo Rivers** with the Wonnangatta River to be started within the fortnight. These are bank stabilisation works with landholders under Environmental Works agreements and sites adjacent to public infrastructure and assets. These works will continue for the next 12 months. Follow up revegetation will occur across all sites.
- 40 Fish Habitat structures were installed on the **Lower Mitchell River** between Picnic Point and the Lind Bridge.
- An investigation into Barriers to fish passage on **Prospect Creek and the Buchan River** will commence within the coming Month.
- Site maintenance, weed control and guard removal was undertaken on the **Wonnangatta River** in preparation for planting to commence within the coming weeks.
- Weed control continues in **Dargo** in preparation for upcoming revegetation.

Tambo Catchment

- The Lower Tambo options Analysis has begun on the lower **Tambo River**. The aim of this project is to provide management options for the future management of the Tambo River and adjoining floodplain and wetlands.
- The Upper **Tambo River** rehabilitation has begun with weed control currently being undertaken.
- The on-ground works have been completed by landholders in the Tambo Valley, who are undertaking weed control works along **Tambo River** frontages.
- Willow control on the **Nicholson River** will be completed within the coming week with more being found than expected.
- Willow control will commence in the coming weeks on the **Upper Tambo River** from the headwaters to Swifts Creek. This will see all juvenile willows being treated in areas they have been previously controlled.
- Bank Stabilisation works have commenced on the lower **Nicholson River**. These works are complimenting previous bank stabilisation works will join up previous rocking efforts to secure the banks.
- Poplar control and weed control works have commenced on the **Tambo River** in two locations, immediately below the Swan Reach bridge and upstream of the Stephensons road bridge. These works are in preparation for further Poplar removal works which will be undertaken in the coming weeks.
- Flood response Bank stabilisation works have begun with Landholders under Environmental works Agreements with the EGCM. These works will be completed within the coming weeks. With follow up revegetation to be planted in spring.
